

**PREVENTION OF COMMUNAL AND TARGETED VIOLENCE (ACCESS TO  
JUSTICE AND REPARATIONS) BILL, 2011**

*CHAPTER I*  
**PRELIMINARY**

<p><b>1. Short title, extent and commencement.-</b> (1) This Act is called “Prevention of Communal and Targeted Violence (Access to Justice and Reparations) Act, 2011”.</p> <p>(2) It extends to the whole of India. <p><b>2. Punishment of offences committed beyond, but which by law may be tried within, India.-</b> Any person liable under any Indian law including this Act, to be tried for an offence committed beyond India shall be dealt in accordance with the provisions of this Act for any act committed beyond India in the same manner as if such act had been committed within India.</p>	<p>s. 3, Indian Penal Code, 1860</p>
<p><b>3. Definitions.-</b> In this Act, unless the context otherwise so requires:-</p> <p>(a) <b>“Armed Forces or Security Forces”</b> means Armed Forces of the Union or Security Forces or Police Forces, as specified in Schedule I.</p> <p>(b) <b>“association”</b> means any combination or body of individuals, whether or not registered or incorporated under any law for the time being in force;</p> <p>(c) <b>“communal and targeted violence”</b> means and includes any act or series of acts, whether spontaneous or planned, resulting in injury or harm to the person and or property, knowingly directed against any person by virtue of his or her membership of any group, which destroys the secular fabric of the nation;</p> <p>(d) <b>“fund”</b> means the Communal and Targeted Violence Relief and Rehabilitation Fund established under this Act;</p> <p>(e) <b>“group”</b> means a religious or linguistic minority, in any State in the Union of India, or Scheduled Castes and Scheduled Tribes within the meaning of clauses (24) and (25) of Article 366 of the Constitution of India;</p> <p>(f) <b>“hostile environment against a group”</b> means an intimidating or coercive environment that is created when a person belonging to any group as defined under this Act, by virtue of his or her membership of</p>	<p>s. 2(c), Protection of Children From Sexual Offences Bill, 2011</p> <p>s. 2(a), Unlawful Activities (Prevention) Act, 1967</p>

<p>(m) In the event this Act is extended to the State of Jammu and Kashmir, any reference in this Act to a law, which is not in force in the State of Jammu and Kashmir, shall, in relation to the State, be construed as a reference to a corresponding law, if any, in force in that State.</p>	
<p><b>4. Knowledge.-</b> A person is said to knowingly direct any act against a person belonging to a group by virtue of such person's membership of that group where:</p> <p>(a) he or she means to engage in the conduct against a person he or she knows belongs to that group; or,</p> <p>(b) with the knowledge that the person belongs to a group, he or she means to cause injury or harm to such person because of the membership of such person to that group.</p>	<p>New provision. <p><i>CHAPTER II</i> <b>OFFENCES</b></p>	
<p><b>5. Offences of communal and targeted violence.-</b> Offences under section 7 to 12 (both inclusive) shall be offences of communal and targeted violence.</p>	
<p><b>6. Applicability of SC/ST Atrocities Act.-</b> (1) In relation to offences against Scheduled Castes and Scheduled Tribes, this Act shall apply in addition and not in derogation of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 except to the extent mentioned in sub-section (2) and (3).</p> <p>(2) The provision of rule 6 and 7 framed under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Rules, 1995 in relation to investigation of offences under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 shall apply to all investigation under that Act to the exclusion of section of section 62 and section 85 of this Act.</p> <p>(3) The provisions of Chapter VII of this Act shall apply to members of the Scheduled Castes and Scheduled Tribes against whom offences are committed under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 to the extent relevant.</p> <p>Provided that any amounts paid under the said Act shall be set off against any amounts paid under this Act.</p>	
<p><b>7. Sexual assault.-</b> A person is said to commit sexual assault if he or she commits any of the following acts against a person belonging to a group by virtue of that person's membership of a group:</p> <p>(a) against a woman,</p> <p style="padding-left: 20px;">(i) rape;</p> <p style="padding-left: 20px;">(ii) gang rape;</p> <p style="padding-left: 20px;">(iii) mass rape.</p> <p>(b) against any person, without their consent or against their will,</p> <p style="padding-left: 20px;">(i) the introduction by a man of his penis or any other body part or</p>	

<p>an object into vagina, mouth or anus, to any extent;</p> <p>(ii) causing harm or hurt to reproductive organs or genital organs;</p> <p>(iii) exposing one's sexual organs in front of any person;</p> <p>(iv) sexual contact of any sort, including the performance of sexual acts for any length of time;</p> <p>(v) removing the persons clothes, partially or fully, or compelling that person to undress himself or herself, partially or fully, in public view or otherwise, or parading that person in undressed state in public view or otherwise;</p> <p>(vi) any other act or conduct that subjects that person to sexual indignity.</p> <p><i>Explanation 1</i>– For the purposes of this section, mass rape means the rape of more than one woman belonging to any group.</p> <p><i>Explanation 2</i>– For the purposes of this section, consent shall mean –</p> <p>(a) The unequivocal voluntary agreement where the person has by words, gestures, or any form of non-verbal communication, communicated willingness to participate in the act referred to in this section;</p> <p>(b) “Unequivocal voluntary agreement” means willingness given for specific and be limited to the express act consented to under this Section.</p> <p><i>Explanation 3</i> – For the purposes of this section, consent shall not be caused by duress, threat, terror, fear, coercion, undue influence, misrepresentation or mistake of fact.</p>	<p>Explanation 1 to s. 3, Protection of Children from Sexual Offences Bill, 2011</p> <p>New provision</p>
<p><b>8. Hate propaganda.</b>– Notwithstanding anything contained in any other law for the time being in force, whoever publishes, communicates or disseminates by words, either spoken or written, or by signs or by visible representation or otherwise acts inciting hatred causing clear and present danger of violence against a group or persons belonging to that group, in general or specifically, or disseminates or broadcasts any information, or publishes or displays any advertisement or notice, that could reasonably be construed to demonstrate an intention to promote or incite hatred or expose or is likely to expose the group or persons belonging to that group to such hatred, is said to be guilty of hate propaganda.</p>	<p>s. 153A, Indian Penal Code, 1860; See also s. 5, The HIV/AIDS Bill, 2007</p>
<p><b>9. Organized Communal and Targeted Violence.</b>– (1) Whoever, being an individual, singly or jointly with others or being a part of an association or on behalf of an association or acting under the influence of an association, engages in continuing unlawful activity of a widespread or systematic nature knowingly directed against a group or part thereof, by virtue of their membership of that group, by use of violence or threat of violence or intimidation or coercion or other unlawful means, is said to commit the offence of organized communal and targeted violence.</p> <p><i>Explanation</i> - for the purposes of this section, ‘continuous unlawful activity of a widespread or systematic nature knowingly directed against a group or part thereof’ means the course of conduct involving the multiple or</p>	<p>s.2(e), Maharashtra Control of Organised Crimes Act, 1999; See Also Art. 6 and 7, ICC Rome Statute</p>

<p>mass commission of acts referred to in this section, whether spontaneously or planned, whether over a short or prolonged period or in one place or a number of places simultaneously or otherwise, against any group or part thereof.</p> <p>(2) Where it is shown that continuing unlawful activity of a widespread or systematic nature has occurred, it could be reasonably presumed that the public servant charged with the duty to prevent communal and targeted violence has failed to act to prevent the widespread or systematic unlawful activity.</p>	
<p><b>10. Aiding financially, materially or in kind for commission of offence under this Act.-</b> Whoever knowingly expends or supplies any money or any material or aids in kind thereof, in furtherance or in support of an act which is an offence under this Act is said to be guilty of aiding financially in the commission of an offence under this Act.</p>	<p>s. 14, The Communal Violence (Prevention, Control and Rehabilitation of Victims) Bill, 2005</p>
<p><b>11. Offence under the Indian Penal Code, 1860.-</b> The offences under the Indian Penal Code, 1860 provided in:</p> <p>(a) Schedule II, Part A of this Act; or</p> <p>(b) Schedule II, Part B of this Act, when committed against any person belonging to a group by virtue of his or her membership to that group,</p> <p>shall be deemed to be offences of communal and targeted violence under this Act and shall be dealt with accordingly.</p>	
<p><b>12. Torture.-</b> Whoever, being a public servant, or under the control or direction of or with the acquiescence of a public servant, intentionally inflicts pain or suffering, whether mental or physical, on a person belonging to a group by virtue of his or her membership of a group, including causing grievous hurt or danger to life, limb or health or sexual assault, for the purposes of obtaining from him or her or a third person information or a confession or punishing him or her for an act he or she or a third person committed or is suspected of having committed, or intimidating or coercing him or her or a third person, is said to inflict torture.</p> <p>Provided that nothing contained in this section shall apply to any pain, hurt or danger as aforementioned caused or inflicted in accordance with law.</p>	<p>Art. 1, UN Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, 1984</p>
<p><b>13. Dereliction of duty.-</b> When any person who is or was a public servant not removable from his or her office save by or with the sanction of the Central Government or State Government, as the case may be, authorized to act under any provision of this Act:</p> <p>(a) exercises the authority vested in him or her colourably or in a manner otherwise than provided under law for the time being in force, which causes or is likely to lead to an offence of communal and targeted violence or by which he or she intends to screen or knowing it to be likely that he or she will thereby screen any person from legal punishment; or,</p>	<p>s. 197, Code of Criminal Procedure, 1973 <b>[Language taken]</b></p>

<p><b>14. Offences by public servants for breach of command responsibility.- (1)</b>  Whoever, being a public servant in command, control or supervision of the Armed Forces or Security Forces as defined under clause (a) of section 3 of this Act or assuming command whether lawfully or otherwise, fails to exercise control over persons under his or her command, control, or supervision and as a result of such failure offences under this Act are committed, by persons under his or her command, control or supervision, or as a result of such failure the said persons fail to discharge their duties under this Act or any other law for the time being in force, shall be guilty of the offence of breach of command responsibility, where:-</p> <ul style="list-style-type: none"> <li>(a) such public servant either knew or ought to have known having regard to the circumstances at the time that the persons under his or her command, control or supervision would commit or be likely to commit such offences; and,</li> <li>(b) such public servant failed to take necessary and reasonable measures within his or her power to prevent or repress the commission of said offences or failed to submit the matter to the competent authorities for investigation and prosecution.</li> </ul> <p>(2) Where it is shown that continuous widespread or systematic unlawful activity has occurred, it can be reasonably presumed that the superior in</p>	<p>Art. 28, Rome Statute of the International Criminal Court, 1998</p> <p>New provision</p>

<p><b>15. Offences by other superiors for breach of command responsibility.-</b> (1) Whoever, being any non-state actor or superior or office-bearer of any association as defined under clause (b) of section 3 of this Act and other than those mentioned under section 14, in command, control or supervision of any association or assuming command vested in him or her or otherwise, fails to exercise control over subordinates under his or her command, control, supervision and as a result of such failure offences under this Act are committed by subordinates under his or her command, control or supervision, shall be guilty of offences committed by such subordinates under his or her command, where:</p> <ul style="list-style-type: none"> <li>(i) such non-state actor or superior or office-bearer of any association either knew, or consciously disregarded information which clearly indicated that his or her subordinates were committing or about to commit such offences;</li> <li>(ii) the offences concerned activities that were within the effective responsibility and control of such non-state actor or superior or office-bearer of any association; and</li> <li>(iii) such non-state actor or superior or office-bearer of any association failed to take all necessary and reasonable measures within his or her power to prevent or repress their commission or to submit the matter to the competent authorities for investigation and prosecution.</li> </ul>	<p>Art. 28, Rome Statute of the International Criminal Court, 1998</p>
<p><b>16. Superior orders and prescription of law.-</b> Where an offence has been committed under this Act, the fact that it was committed by a person pursuant to an order of a superior, shall not relieve that person of criminal responsibility unless:</p> <ul style="list-style-type: none"> <li>(a) The person was under a legal obligation to obey orders of the superior in question; and</li> <li>(b) The order was not manifestly unlawful.</li> </ul>	
<p><b>17. Abetment of an offence.-</b> A person abets an offence, who –</p> <ul style="list-style-type: none"> <li>First – Instigates any person to do that offence; or</li> <li>Secondly – Engages with one or more other person or persons in any conspiracy for the doing of that offence, if an act or illegal omission takes place in pursuance of that conspiracy, and in order to the doing of that offence; or</li> <li>Thirdly – Intentionally aids, by any act or illegal omission, the doing of that offence.</li> </ul> <p><i>Explanation I</i> – A person who, by willful misrepresentation, or by willful concealment of a material fact, which he or she is bound to disclose, voluntarily causes or procures, or attempt to cause or procure a thing to be done, is said to instigate the doing of that offence.</p>	<p>s. 16, Protection of Children from Sexual Offences Bill, 2011</p>



<p>the National Authority for Communal Harmony, Justice and Reparation to exercise the powers and perform the functions assigned to it under this Act.</p> <p>(2) The National Authority shall be a body corporate with the name aforesaid having perpetual succession and a common seal with the power, subject to the provisions of this Act to acquire, hold and dispose of property and to contract, and may, by the aforesaid name, sue or be sued.</p> <p>(3) The National Authority shall consist of a Chairperson, a Vice-Chairperson and five other Members.          Provided that, at all times, not less than four Members, including the Chairperson and Vice-Chairperson, shall belong to a group as defined under this Act. <p><b>22. <p><i>Explanation</i> - For the purposes of this sub-section, “the Leader of the Opposition in the House of the People” shall, when no such Leader has been so recognised, include the Leader of the single largest group in opposition of the Government in the House of the People.</p> <p>(2) The process of selection shall be initiated by the office of the Prime Minister of India within three months of the coming into force of this Act in the first instance and three months prior to the completion of tenure of the existing Chairperson, Vice-Chairperson or Member and shall be concluded within two months.</p> <p>(3) The decisions of the Selection Committee shall be by a simple majority.</p>	
<p><b>23. Qualifications.-</b> (1) The Chairperson, Vice-Chairperson and Members of the National Authority shall have the following qualifications and shall be chosen from amongst persons:</p> <ul style="list-style-type: none"> <li>(a) having expertise in relation to law or criminal justice or human rights;</li> <li>(b) having a record of promoting communal harmony;</li> <li>(c) being of high moral character, impartiality and integrity; and,</li> <li>(d) who have not been members of any political party for a period of one year prior to their selection.</li> </ul> <p>(2) No person shall be eligible to be appointed as a Chairperson, Vice-Chairperson or Member of the National Authority if:</p> <ul style="list-style-type: none"> <li>(a) an inquiry into an offence under any law for the time being in force is pending against him or her or he has been convicted for such offence;</li> <li>(b) he or she has, in any manner, exhibited bias against any group, by acts or in writing or otherwise; or</li> <li>(c) if subject to any disciplinary control, whether a public servant or otherwise, a disciplinary proceeding is pending against him or her, or he or she has been found guilty in any such proceeding.</li> </ul> <p>(3) The Chairperson, Vice-Chairperson and Members of the National Authority shall not contest elections for a period of two years after completion of their term either under the Government of India or under the Government of any State except to the office of President or Vice President of the Union of India.</p>	
<p><b>24. Term of office of Members.-</b> (1) The Members of the National Authority shall serve on a full-time basis for a six year term.</p> <p>Provided that at the first selection, two members shall be appointed for a term of two years, two members for a term of four years, and the remainder appointed for a term of six years.</p> <p>(2) A person appointed as Chairperson or Vice-Chairperson shall hold office for a term of two years from the date on which he or she enters upon his or her office.</p>

**94. Duties in relation to relief camps.-** Until such time as any persons mentioned under section 90 are located in relief camps, it shall be duty of the State Government and, in particular, the Collector, either by himself or herself or through his or her subordinates to ensure the following:

- (a) an environment free from any exposure to or occurrence of any form of sexual assault, exploitation, intimidation, violence, or forced labour in the relief camps;
- (b) provision for family members of one household unit to remain in the same relief camp or if they wish, relocate together to another relief camp, or if separated, then to enable them to reunite as soon as possible by taking all steps to expedite the location and reunion of such families, particularly children and parents;
- (c) establishment of a single window system to complete all administrative formalities in relation to provision of quick relief and rehabilitation, including making available identity documents, certificates, ration cards, passports, speedy disposal of insurance and other claims, provision for certification of loss or damage of educational or other certificates or ownership or other documents in respect of all persons mentioned under section 90;
- (d) restoration of all official documents of such persons mentioned under section 90 that include but are not limited to ration cards, property proofs, government cards and identities, school and college related documents, election cards at the earliest but in any case not later than three months shall be the responsibility of the State Government;
- (e) facilitation for the students affected by organised communal and targeted violence to appear for any examination, condoning delays caused by such violence, and to provide for such facilitation, including creating support centres for the same.
- (f) provision for victims to file information in relation to offences under this Act and record statements in pursuance of any complaints related to organised communal and targeted violence;
- (g) provision for all persons mentioned in section 90 to claim and receive compensation while still in the relief camps;
- (h) provision of a single window system for all persons mentioned in section 90 to make enquiries and give information about the status and whereabouts of missing family members, relatives or friends and assist them in receiving such information as desired with regard to the progress of investigation of the whereabouts and condition of such missing persons;
- (i) access to legal aid in the prosecution of offences under this Act.

Provided that special efforts shall be made to ensure the full participation of all persons mentioned under section 90 and, in particular, women, in the planning and distribution of basic services and supplies;

Provided further that, such assistance may be organized with the help of individuals and groups including human rights groups, and
